**ORDER**

The Director of Tourism as per letter read above has reported to Government that the completion of the project has taken a longer duration since the research for Developing a Microsite of Champions Boat League is deep rooted in the history and tradition of Kerala. Taking into account the delay experienced in the completion of the project the Director of Tourism has requested to re-validate the administrative sanction accorded during the FY

2022-24 for the project "Developing a Microsite of Champions Boat League" as per the Government order read (2) above, for meeting the expenditure during the current financial year .
