ORDER

The Registrar General, High Court of Kerala vide letter read as 1st paper above forwarded proposals worth Rs. 19,96,36,000 (Rupees Nineteen Crores Ninety Six Lakhs Thirty Six Thousand only) under Annual Plan 2025-26 for according Administrative Sanction. The Director of Prosecution vide letter read as 2nd paper above forwarded proposals under Annual Plan 2025-26 worth Rs. Rs.4,14,00,000/- (Rupees Four Crores Fourteen Lakhs only) for according Administrative Sanction by meeting the expenditure under the head of account "2014-00-114-90".

2. Government have examined the proposals furnished by the Registrar, High Court of Kerala and the Director of Prosecution in detail, based on the recommendations of the Departmental Working Group meeting held on 14-05-2025 and are pleased to accord Administrative Sanction for a total amount of Rs. 19,96,36,000/-(Rupees Nineteen Crores Ninety Six Lakhs Thirty Six Thousand only) for the Schemes/ components pertaining to the High Court of

The following conditions shall be strictly adhered to:

- i. All computers and such other items shall be procured through CPRCS (Centralized Procurement and Rate Contract System) and if they are not available in CPRCS, shall be procured through GeM.
- ii. The Registrar General, High Court / Director of Prosecution is responsible for execution, supervision and monitoring of the works of the respective departments. This should be done during the financial year and monthly monitoring shall be carried out on the 15th of every month.
- iii. Since Economy orders are in force regarding purchase of furniture,

the proposal should be furnished to Finance Department with details of items and their fair price.

vi. Regarding hiring of vehicles, prior sanction from the Government should be obtained.

vii. For the Purchase / Maintenance of electronic and electrical devices in the Directorate of Prosecution/High Court the proposal should be placed before the Internal Technical Committee of the Department and the decision will be taken only after scrutiny by both E& IT and Finance Departments.
