ORDER

Consequent to the retirement of Smt.V.Geetha, Vigilance Tribunal, Kozhikode, a vacancy of Vigilance Tribunal arose with effect from 01.06.2024. Subsequently, a notification was published in the Gazette Extraordinary read 2nd above, inviting applications from qualified candidates for appointment to the post of Vigilance Tribunal, Kozhikode. 22 candidates have applied for the post in response to the notification.

2. Government as per G.O read 3rd above had constituted a Selection Committee for the selection to the post of Vigilance Tribunal, Kozhikode comprising of Mr.Justice V.K Mohanan (Rtd) as the Chairman, Secretary, Law department as the Member and the Additional Chief Secretary, Home & Vigilance Department as the Convenor. The Selection Committee in its first meeting held on 30.08.2024 authorized the Convenor to verify all the applications received (22Nos) and submit the verification report. Subsequently, 14 candidates, who have submitted valid applications have been shortlisted

for the interview scheduled on 15.11.2024, and call letters for attending the interview have been sent to them.

3. The Selection Committee conducted the interview of the shortlisted candidates on 15.11.2024. In its last meeting held on 18.11.2024, the Selection Committee decided to recommend the first rank holder in the interview, Sri.Suraj. C.P, Sumathi Nivas, Kannankara, Chelannur, Kozhikode- 673 616, to the Government for appointing as Vigilance Tribunal, Kozhikode.

4. Government have examined the recommendation in detail and found that Sri.Suraj. C.P, Sumathi Nivas, Kannankara, Chelannur, Kozhikode- 673 616 ranked 1st is suitable for appointment as Vigilance Tribunal, Kozhikode. The Director, Vigilance & Anti Corruption Bureau, as per letter read 4th above, has reported that there is no vigilance case/enquiry against him.

5. In the above circumstances, Government is pleased to appoint Sri.Suraj. C.P, Sumathi Nivas, Kannankara, Chelannur, Kozhikode- 673 616, who is presently serving as Legal Advisor in Vigilance & Anti Corruption Bureau, Northern Range, Kozhikode as Vigilance Tribunal, Kozhikode, under Rule 3 of the Kerala Civil Services (Vigilance Tribunal) Rules, Rules 1960, as amended by G.O (P) No.26/2017/Vig dated 13.9.2017 published as S.R.O No. 569/2017 in the gazette Extra Ordinary No.2014 dated 20.9.2017.

6. Sri.B.Premnath, Vigilance Tribunal, Thiruvananthapuram, who has been holding the full additional charge of Vigilance Tribunal, Kozhikode, as per order read 1st above, will hand over the charge to Sri.Suraj. C.P forthwith.
