<u>ORDER</u>

In compliance to the Final Judgement of the Hon'ble High Court of Kerala in Writ Petition (Civil) No.13694/2020 read as 2nd paper above, Government have accorded sanction to write off the outstanding loan amount of Rs. 4,03,501/- taken by Smt. Ressy Mol Babu (mother of Kumari. Ann Mariya,) & Shri. Chacko Mathew (Mother's father of Ann Mariya,) from State Bank of India, Kadumeni branch, Kasaragod and Canara Bank, Chittarikkal branch, Kasaragod respectively, as a special case, vide GO read as 4th paper above.

2. As per letter read as 3 rd paper above the District Collector, Kasaragod has requested the Government to clarify the amount specified in the Government Order read as 4th paper above, as the write-off amount did not include the interest portion of the loan taken from the SBI, Kadumeni Branch.

Government have examined the matter in detail and are pleased to write-off the outstanding loan amount (Principal Amount & Interest Amount) of Rs. 4,09,502/- [Rs. 75,001/- + Rs. 3,34,501/-] taken by Smt. Ressy Mol Babu (Mother of Kumari. Ann Mariya,) & Shri. Chacko Mathew (mother's father of Ann Mariya,) from State Bank of India, Kadumeni branch, Kasaragod and Canara Bank, Chittarikkal branch, Kasaragod respectively , by exempting the existing norms stipulated in the Government Order read as 1st paper above, considering as a special case.
