The Chief Engineer, PWD Roads Division ,Thiruvananthapuram vide letter read as above has requested to accord Administrative Sanction for the work - General-Budget work 2025-26-(substitution) Chenganda-Thrichattukulam MLA Road from ch:1/1500 to 6/000 in Aroor LAC - for an estimated amount of Rs. 600 Lakhs (Rupees Six Hundred Lakh only.) in the H/A 5054-04-337-99 MDR.

2. Government have examined the matter in detail and are pleased to accord Administrative Sanction for the work - General-Budget work 2025-26-(substitution) Chenganda- Thrichattukulam MLA Road from ch:1/1500 to 6/000 in Aroor LAC - for an estimated amount of Rs. 600 Lakhs (Rupees Six Hundred Lakh only) under the H/A 5054-04-337-99 MDR subject to the following conditions.

1. The provisions of shoulder concreting shall be limited to essential locations which shall be specified in the TS estimate

2. Chainages of various provisions shall be ensured in the TS estimate.

3. The TS authority shall ensure that the design of retaining walls in the approach road is carried out in compliance with the directions issued in the prevailing CTE circulars.

4. The correctness of the rates adopted for the observed data included in the estimate if any, shall be ensured by the TS authority.
