ORDER

ANERT is currently implementing the PM KUSUM solarization project for 5955 agricultural pumps using funds from NABARD – RIDF.

2. As per the order read as 1st paper above, NABARD approved a total of Rs.172.05 Crore for the above solarisation works and as per the Government order read as 2nd paper above Government have accorded Administrative Sanction for the project "Solarisation of 5955 Agriculture pump sets in the State of Kerala under Component 'C' of PM-KUSUM Scheme of MNRE, Government of India" under RIDF Tranche XXVIII (2022-23) with a total financial outlay of Rs.18111.47 Lakhs

(RIDF loan Rs.17205.62 Lakhs+State Government share - Rs.905.85 Lakhs) as approved by the NABARD RIDF Tranche XXVIII 2022-23.

3. As per the letter read as 3rd paper above, Chief Executive Officer, ANERT has requested sanction for the 11th Reimbursement Claim for PM KUSUM Component C project under RIDF – XXVIII Tranche.

4. As per Government Order read as 4th paper above, an amount of Rs.491.42 Lakh has been additionally authorized under the h/a "6810-00-188-99-Solarization of 5955 Agriculture pump sets under Component C of PM KUSUM Scheme (PV)" for the release towards 10th and 11th RC of the project.

5. Government have examined the matter in detail and are pleased to sanction to release an amount of of Rs.256.66 Lakh (Rupees Two Hundred Fifty Six Lakh Sixty Six Thousand only) to ANERT under the h/a '6810-00-188-99 - Solarisation of 5955 Agriculture pump sets under Component 'C' of PM-KUSUM Scheme (PV)' as the 11th RC claim under RIDF Tranche XXVIII (2022-23) implementing through 'ANERT (Plan)' subject to the condition that the Chief Executive Officer, ANERT shall take timely steps to regularize this additional expenditure through Re appropriation of Savings only within the grant before the close of the current financial year.
