ORDER

WHEREAS, it has been disclosed from the records of investigation in Crime No.493/2025 of Karipur Police Station that the accused Hameed KP, S/o Abdullakoya, KP House, Maniyal Paramba, Olavanna, Kozhikkod had fraudulently obtained Indian Passport bearing No.A 0578248 under the name and address of Vallil Paramba Abdul Hameed, S/o Abdulla Kota Vallil Paramba, Vallil Paramba Pathappiriyam P O . Subsequently, he renewed the said passport as F 6320503 & N 1426359. On 02.07.2025 he arrived at Calicut International Airport from Dubai by flight number IX 344/(DXB) with an Emergency Certificate bearing number X 1121941 and three passports bearing numbers A 0578248, F 6320503, N 1426359. Upon verification, it was revealed that, the passenger details such as name, date of birth, address and father's name in Passport were all different with the details in his Adhar Card, Driving License and Voter ID Card. Thus the accused Hameed KP violated Passport Act and Rules and committed

offences punishable under section 336(2), 340(2) of Bharatiya Nyaya Sanhita, 2023 and section 12(1)(a) & 12(1)(b) of the Indian Passport Act, 1967.

AND WHEREAS, the Government of Kerala after careful examination of the records of investigation in Crime No.493/2025 of Karipur Police Station are fully satisfied that the aforesaid accused Hameed KP committed offences punishable under section 12(1)(a) and 12(1)(b) of the Passport Act, 1967 along with other offences for which he should be prosecuted.

NOW THEREFORE, Government of Kerala, in exercise of the powers conferred by section 15 of the Passports Act, 1967 read with Government of India Notification No. GSR 662(E), dated 01.12.1979 of the Ministry of External Affairs do hereby, accord sanction to prosecute the accused Hameed KP, for the offences punishable under section 12(1)(a) and 12(1)(b) of the Passport Act, 1967, in Crime No.493/2025 of Karipur Police Station and for taking cognizance of the said offences by a court of competent jurisdiction.
