## **ORDER**

As per the Government Order read as 1<sup>st</sup> paper above, during the financial year 2023-24, Administrative Sanction was accorded to e-Health Kerala for utilizing Rs.883.35 lakh under the head of account '2210-01-001-88(PV) for implementation of the scheme 'Kerala Digital Health Mission - e Health Programme'. However, since the Administrative Sanction was issued towards the end of the financial year and the work of setting up of e-Health was then in the initial stages, no fund release was effected in the financial year 2023-24. Therefore, the same was posted in e-LAMS during the financial year 2023-24. Later, based on the actual requirement, the Project Director, e Health Kerala had submitted proposal for the release of funds amounting to Rs.714.37 lakh, during the financial year 2024-25, however, vide Government Order read as 2<sup>nd</sup> paper above Government released Rs.339.68 lakh.

**2.** As per the letter read as 3<sup>rd</sup> paper above, the Project Director, e Health Kerala has informed that at present, certain works under the items sanctioned vide Government Order read as 1<sup>st</sup> paper above have been initiated and in order to ensure timely payments, an amount of

Rs.3,54,69,000/- is required to be released from the Current Year's Budget provision, in light of the Administrative Sanction already sanctioned.

3. Government have examined the matter in detail and are pleased to release 50% of the required amount. Accordingly sanction is hereby accorded to release Rs.1,77,34,500/- (Rupees One Crore Seventy Seven Lakh Thirty Four Thousand and Five Hundred Only) from the budget provision for the financial year 2025-26 under the head of account '2210-01-001-88(P) - Kerala Digital Health Mission - e Health Programme' in the light of the Administrative Sanction already accorded vide Government Order read as 1<sup>st</sup> paper above, on a condition that the remaining amount will be released only after the submission of relevant bills.
