ORDER

As per the order read 1st above, sanction was accorded for the establishment of a new Court of the Enquiry Commissioner and Special Judge with headquarters at Kollam and for the creation of necessary posts for its functioning. Accordingly, as per the recommendation of the Director, Vigilance and Anti-Corruption Bureau and the Registrar General, High court of Kerala, sanction was accorded, as per the G.O read 2nd above, to commence the newly established Court of the Enquiry Commissioner and Special Judge and the office of the Public Prosecutor in Kottarakkara Municipality, in the building bearing door

number IX/64, in which the Fast Track Court (POCSO) was functioned earlier.

2. Thereafter, as per the letter read 3rd above, the Hon'ble High Court of Kerala informed that it has been decided to demolish the above building and recommended to review the Government's decision to establish the Court of the Enquiry Commissioner and Special Judge at Kottarakkara. Accordingly, Government has stopped all further action pursuant to the order read 2nd above.

3. Subsequently, the Director, Vigilance and Anti-Corruption Bureau, as per letter read 4th above, has recommended that building No. 11/2710-1074, owned by Sri. Dani Yesudasan located at Mathilil, Thrikkadavur Village in Ward No. 11 of Kollam Corporation, is suitable for housing the new Vigilance Special Court. The Registrar (District Judiciary), High Court of Kerala, as per letter read 6th above, has affirmed that the proposed building is suitable for establishing the new Vigilance Court. The District Collector, Kollam has also recommended the same building, vide letter read 5th above.

4. Government examined the matter in detail and is pleased to accord sanction to commence the newly established Court of the Enquiry Commissioner and Special Judge and the office of the Public Prosecutor in the Building bearing No.11/2710-1074 in Ward No. 11 of Kollam Corporation, situated in the land comprised in Resurvey No. 461/12-3, 461/13-2, 461/13-3 and 461/25 in Block No. 2 in Thrikkadavur Village, Kollam Taluk, owned by Sri. Dani Yesudasan, subject to the following conditions.

i. Adequate public toilets as per the building rules applicable, sufficient parking space and car shed to accommodate the official car of the Judge and Prosecutor should be provided by the building owner. Necessary alteration and modification works are to be carried out by the building owner before taking possession of the building on rent.

ii. The proposal for fixing the rent of the building should be prepared and submitted for the decision of the Government, in accordance with the existing guidelines.

5. The Enquiry Commissioner and Special Judge, Thiruvananthapuram (Unit Coordinator) and the Director, Vigilance & Anti-Corruption

Bureau will take further necessary action to get the new Vigilance Court and the office of the Public Prosecutor operational.
