ORDER

The Chief Engineer, Project 1 vide letter read above, submitted a proposal for the "Malampuzha Canal, Peringottukurissi Panchayat Pilappulli Cut and Cover Construction and Beautification Palakkad district" instead of " EMS Memorial Senior Citizen Park" which was included as serial number 986 in the list of construction works, without Administrative Sanction and Local Self-Government Department, was made the implementing agency and an expenditure of Rs. 50 lakhs and a provision of 20% was sanctioned in the Budget of 2024-25.

2) Government have examined the matter in detail are pleased to accord sanction for "Malampuzha Canal, Peringottukurissi Panchayat- Pilappulli Cut and Cover Construction and Beautification Palakkad district" for an amount of Rs. 50 lakhs subject to the following conditions:

1. The Chief Engineer shall ensure that the works proposed in the estimate satisfy the functional requirements as envisaged.
2. TS authority shall ensure the foundation requirements of the cut and cover based on detailed soil investigation done through Government approved agencies having good expertise in this area before issuing the Technical Sanction.

3. The Structural Design is not seen done for the proposed cut and cover. Hence, the structural adequacy and structural stability shall be ensured before issuing the Technical Sanction considering economy.

4. The TS authority shall ensure proper discharge through the cut and cover and provide adequate ventilation, if required.

5. TS authority shall ensure the correctness of the rates adopted for observed data provided in the estimates and the quality of materials during the time of execution.

6. The competent authority shall ensure the admissibility of provisions included in the estimate with the site conditions before issuing the Technical Sanction.


