ORDER

Administrative sanction was accorded as per Government Order read above for engaging the Kerala University of Digital Sciences, Innovation and Technology to conduct a Functional Requirement Study and prepare a Detailed Project Report(DPR) for the digitalization of the Kerala Lok Ayukta, at an estimated cost of Rs. 8,26,000/- (Rupees Eight lakh twenty-six thousand only). Sanction was also accorded for the advance payment of Rs.3,30,400/- (Rupees Three lakh thirty thousand and four hundred only) to the Kerala University of Digital Sciences, Innovation and Technology for this purpose.The expenditure in this regard was to be met under the Head of Account “2062-00-103-99-99”.

2. The Registrar, Kerala Lok Ayukta, as per the letter read above, has reported that the balance payment towards the cost of the work study for the digitalization project is anticipated to be incurred during the financial year 2025–26. As the advance amount of Rs.3,30,400/- was utilized from the Head ‘Other Items’, The Registrar, Kerala Lok Ayukta has requested for incorporating the new Head of Account "2062-00-103-99-99" for meeting the remaining expenditure.

Government examined the matter in detail and is pleased to re-validate the Administrative Sanction issued as per the Government Order read above, for engaging the Kerala University of Digital Sciences, Innovation and Technology to conduct the Functional Requirement Study and prepare the Detailed Project Report for the digitalization of the Kerala Lok Ayukta, at the estimated cost of ₹8,26,000/- (Rupees Eight lakh twenty-six thousand only).

4. The Head of Account “2062-00-103-99-99” will be opened as and when the payment becomes due after completing the work, for meeting the expenditure related to this project.
