ORDER

As per the Government Order read as 1st paper above, Administrative Sanction was accorded for the project 'Construction of Common Drainage system for proper sewage management to prevent beach pollution at Athiyannoor Block in Thiruvananthapuram District of Kerala- under NABARD RIDF Scheme at a total financial outlay of Rs.382 lakh with NABARD RIDF XXX loan under the Head of Account 5051-01-001-99 Development of Vizhinjam Deep Water International Transshipment Terminal (PV) by implementing through Harbour Engineering Department within the projects completion period as per the issued terms and conditions of RIDF works.

As per the letter read as 2nd paper above, the Chief Engineer, Harbour Engineering Department has reported that 80% of the works were completed and as per the letter read as 3rd above has requested to release an amount of Rs.3,82,00,000/- to the Harbour Engineering Department under the H/A 8443-00-108-00-00-00-00 for the project.
