### ORDER

As per letter read above, the Chief Engineer, KSRRDA has reported that the agreement of work having Package No. KR-08-88 MRL08-Chittari Panolakkav - Vanimel Kavu Road in Kozhikode was executed on 14.09.2023 under PMGSY-III. But due to heavy land side occurred on 30.07.2024, the road was damaged partly. Approximately 290m length of DR masonry with top belt and guard stone was completely damaged, from ch 0/160 to 0/260 and width reduced from 8m to 1.50m and in some of the area deep valley formed due to land side. For the restoration of the road, the Executive Engineer prepared a detailed estimate for the package for an amount of Rs. 87,66,093/- including 18% GST as per PRICE rates. The Chief Engineer, KSRRDA has requested to accord Administrative Sanction for the same.

2) Government have examined the matter in detail and are pleased to accord Administrative Sanction for the estimate of the restoration work on “PMGSY III 2023-24 Package No. KR-08-88 MRL08-Chittari Panolakkav-Vanimel Kavu Road in Kozhikode” for an amount of ₹87,66,093/- (Rupees Eighty Seven Lakh Sixty Six Thousand and Ninety Three only) subject to the following conditions;

1. TS authority shall ensure that the proposed retaining wall is designed as per prevailing CTE circulars.

2. The correctness of the rates adopted for the observed data included

in the TS estimate if any, shall be ensured by the TS authority.

3.The competent authority shall ensure the admissibility of provisions included in the estimate with the site conditions before issuing the Technical Sanction (TS).

4. The working chainages shall be ensured by the TS authority.

5.TS authority shall ensure that the proposed restoration work is arranged only at the damaged road portions (due to landslide), which are part of the ongoing project.

6. The restoration work may commence only after inspection of the site by officers from the Finance Inspection - Technical.
