ORDER

As per the Government Order read as 1st paper above, the Administrative Sanction for an amount of Rs.13,51,06,326/- including GST (Rupees Thirteen Crore Fifty One Lakhs Six Thousand Three Hundred and Twenty-Six Only) has been accorded for the "Construction of 50 bedded integrated Ayush Hospital Kappukkad- Thiruvananthapuram District (60%CSS)". After getting the Administrative Sanction, the National Ayush Mission has been allotted the work to M/s WAPCOS Ltd as implementing agency. The detailed TS schedule of the above work has been submitted by WAPCOS Limited to State Mission Director National Ayush Mission, and the SMD, NAM has requested to accord Technical Sanction for the project as per the letter read as 3rd paper above. The Technical Sanction Committee constituted as per the Government Order read as 2nd paper above convened on 22/01/2026, scrutinized the detailed estimates of the project and accord Technical Sanction as detailed in the minutes read as 4th paper above.

2) Accordingly, Government are pleased to accord Technical Sanction for an amount of Rs.12,86,02,180/- (including GST, Electrical Inspectorate Inspection & Testing fees, KSEB connection charges) for the work “Construction of 50 bedded integrated Ayush Hospital Kappukkad- Thiruvananthapuram District (60%CSS)” as detailed below.
