ORDER

The State Police Chief as per letter read above has informed that the District Police Chiefs in Malappuram & Kollam City have requested to take necessary steps to shift CCTV cameras installed at Vazhakkad Police Station of Malappuram and at Karunagappally & Kilikolloor Police Stations of Kollam City to the newly constructed buildings. The State Police Chief has informed that a proposal has been received from M/s. Telecommunication Consultants India Limited (TCIL), the implementing agency of the current CCTV surveillance system, for the dismantling and re-installation of CCTV equipment in the new Police Station building with an estimate amount of Rs.1,26,151/- per police station. Therefore it is requested to accord administrative sanction for an amount of Rs.3,78,453/- under the head of account '4055-00-207-88-installation of CCTV cameras in Police stations' for the dismantling, installation, testing, commissioning, operationalizing and maintenance of IP-based CCTV surveillance security cameras in the newly constructed buildings at Vazhakkad Police Station (Malappuram), Karunagappally and Kilikolloor Police Stations (Kollam

City) with M/s. TCIL.
