As per Government Order read 1st paper above, Administrative Sanction for an amount of Rs. 50,00,000/- (Rupees Fifty Lakh only) was accorded to the Centre for Socio-economic and Environmental Studies for under taking the activities proposed for the year 2025-26.

As per the Government Order read 2nd paper above, Government accorded sanction to release an amount of Rs. 20,00,000/- (Rupees Twenty Lakh only) as the first installment of budgetary support from the Head of Account 2202-80-004-84 –Grants-in-Aid – NP to the STSB Account of Centre for Socio-economic and Environmental Studies.

3. As per the letter read above, Director, Centre for Socio-economic and Environmental Studies has requested to release the balance amount of budgetary support for the timely completion of the activities stipulated in the Administrative Sanction.

4. Government have examined the matter in detail and are pleased to

release an amount of Rs. 10,00,000/-(Rupees Ten Lakh Only) towards the second installment of Grant-in-Aid from the Head of Account 2202-80-004-84 – Grants-in-Aid –NP by crediting the amount to the STSB Account No. 799011400002289 of the Centre for Socio-economic and Environmental Studies, maintained at the Sub Treasury, Ernakulam.

5. The Director, Centre for Socio-Economic and Environmental Studies shall submit the utilisation certificate and component wise detailed expenditure statement of the released fund before the next release.

6. The Director, Centre for Socio-Economic and Environmental Studies shall also take timely steps to furnish the audited accounts to Government.
