ORDER

As per the Govt. Order read as 1st above Administration Sanction was accorded for the project of Integrated Aqua Project at Kuthiravattomchira, under RIDF Tranche-XXIX for an amount of Rs.1511 lakh.

2. As per the Govt. Order read as 2nd above mobilisation advance of 2.61 crore, released for the said project .

3. The Director of Fisheries as per the letter read above, furnished the drawal application under Rural Infrastructure Development Fund Tranche XXIX, in the prescribed proforma towards the reimbursement claim of the project "Integrated Aqua Project at Kuthiravattomchira, Chengannur", implemented by Kerala State Coastal Area Development Corporation amounting to Rs.45,97,800 (Rupees Forty five lakh Ninety seven thousand Eight hundred only) for the expenditure incurred from 31/12/2025 to 09/02/2026 and has requested to release fund in this regard.

4. Government examined the matter in detail and pleased to order the following, regarding the project "Integrated Aqua Project at Kuthiravattomchira, Chengannur" under NABARD RIDF Tranche XXIX.

a) The eligible RIDF share of Rs. 43.6791 lakh (Rupees Forty Three Lakh Sixty

Seven Thousand Nine Hundred and Ten only) shall be adjusted against the Mobilization Advance released for the project "Integrated Aqua Project at Kuthiravattomchira, Chengannur".

b) No amount is sanctioned for release for the present reimbursement claim.

c) The balance Mobilization Advance of Rs. 48.36577 lakh, remaining with Kerala State Coastal Area Development Corporation shall be adjusted against future reimbursement claims.

5. The Director of Fisheries shall take necessary follow-up action and ensure that the accounts are updated accordingly.
