ORDER

The XVth Finance Commission has recommended an amount of ₹390 crore consisting 40% as Untied Basic Grant and 60% as Tied Grant for ULB Non-Million Plus cities (All Municipalities except Malappuram) as XV Finance Commission Grant for the year 2024-25.

2) In order to ensure optimal and targeted utilization of XV FC Funds as directed by the Ministry of Housing & Urban Affairs, Government, vide order read as 3rd paper above, have modified the present system of withdrawal of XV Finance Commission Grants by the Local Governments. As per Government order read as 4th paper above, LGs were granted permission to open Bank account for operating XV FC Grant through PFMS platform.

3) The Director, FCD vide, letter read as 5th paper above, has conveyed the release of 2nd installment of Tied Grant to Non-Million Plus cities (NMPCs) as recommended by the 15th Finance Commission for the year 2024-25 amounting to ₹117.00 crore and requested to distribute the Grant on the basis of the recommendations of the latest State Finance Commission.

4) Government, after having examined the matter in detail, are pleased to issue the following orders:

- a) An amount of ₹117,00,00,000 /- (**One Hundred Seventeen crore only**) is authorized to Urban Local Bodies (All Municipalities except Malappuram) and Cannanore Cantonment Board as 2nd instalment of Tied Grant to Non-Million Plus cities (NMPCs) under XV FC Award for the FY 2024-25 as detailed below:

- e) The Director of Treasuries shall make available copies of this order to the Dist/Sub treasuries through Treasury intranet.
- f) The Secretaries of the Local Governments shall make necessary arrangements to transfer credit the amount to their respective PFMS accounts opened for XV FC Grant within 10 days from the date of issue of this order.




