### ORDER

As per the Government Order read above, an amount of Rs.41.80 lakh was sanctioned under the Head of Account 4405-00-104-53(PV) for the project "Upgradation of Matsyafed Ice and Freezing Plant at Ernakulam and Development of Cold Storage Chain in 6 Districts of the State."

2) The Director of Fisheries, as per the letter read above, reported that, due to Treasury restrictions, the allotment could not be placed through BAMS and the amount could not be released to Matsyafed. The Director has therefore requested to revalidate the Government Order to provide an amount of Rs.41.80 lakh under the Head of Account 4405-00-104-53 (PV) for the project "Upgradation of Matsyafed Ice and Freezing Plant at Ernakulam and Development of Cold Storage Chain in 6 Districts of the

State.”

3) Government have examined the matter in detail and are pleased to accord sanction to revalidate the Government Order read above for releasing an amount of Rs.41.80 lakh (Rupees Forty One Lakh and Eighty Thousand only) under the Head of Account 4405-00-104-53(PV) towards the project “Up gradation of Matsyafed Ice and Freezing Plant at Ernakulam and Development of Cold Storage Chain in 6 Districts of the State” implemented by Matsyafed.
