**ORDER**

In the current financial year 2025-26, Government have allocated Rupees One crore under the Head of Account "2070-00-106-94-Strengthening of Civil Defence -34 Other Charges -3 Other Items PV". The Director General, Fire & Rescue Services, as per the letter read as 6 th paper above, requested to issue revised Administrative Sanction for expending Rs.7,98,533 (*Rupees Seven Lakh Ninety Eight Thousand Five Hundred and Thirty Three Only*) from the said Head of Account. The request pertains to those items for which Administrative Sanction had already been accorded vide Government orders read above, but the purchase could not be completed within the sanctioned period.

3. Government have examined the matter in detail and are pleased to accord revised Administrative Sanction for an amount of Rs.7,98,533 (*Rupees Seven Lakh Ninety Eight Thousand Five Hundred and Thirty Three Only*) for the purchase of the following committed items on



condition that no more commitments should be undertaken by virtue of the revised administrative sanction :-
