## **ORDER**

A State Level Monitoring Committee was earlier constituted as per the Government Order cited 1st paper, for the effective implementation of the scheme to grant awards to Good Samaritans who saved the lives of accident victims within the Golden Hour of the accident. The Ministry of Road Transport and Highways, Government of India, has since renamed the scheme as the **Rah-Veer Scheme**, which provides financial incentives and legal protection to individuals who transport road accident victims to hospitals.
