Having examined the matter in detail, Government hereby direct that the Farmer Producer Organizations (FPOs)/ Farmers Producer Companies (FPCs) in the State may be treated at par with other Agriculture Cooperative Societies and State Marketing Federations while granting fertilizer (Urea and DAP) distribution/ dealership licenses and also while distribution/ allotment of fertilizer supplies to these Farmer Producer Organizations (FPOs)/ Farmers Producer Companies (FPCs). Also to extend the concessions/ benefits from Agriculture Department at par with cooperative societies.
