### ORDER

As per the Govt. Order read above, Administration Sanction was accorded for an amount of Rs.461.33 lakh for the project "Establishment of Value Added Fish Processing Centre in Mulakkuzha Panchayat, Chengannur", under NABARD Tranche XXVIII.

2) The Director of Fisheries as per the letter read above has furnished the drawal application under Rural Infrastructure Development Fund - Tranche XXVIII, in the prescribed proforma towards the reimbursement claim of the project "Establishment of Value Added Fish Processing Centre in Mulakkuzha Panchayat.Chengannur" implemented by Matsyafed, incurred for the period September 2025 for an amount of Rs.23.14988 lakh and has requested to accord sanction to release fund in this regard .
