ORDER

As per Government order read as 5th paper above, the first installment of funds under the scheme National Mission for Natural Farming(NMNF) for FY 2025-26 amounting to Rs.424 lakhs under General, SCP and TSP category was released. The sharing pattern for the scheme is in the ratio 60:40 and is implemented through the SNA for the first installment and now through SNA-SPARSH. Now as per letter read as 6th paper above, Government of India has accorded first mother sanction in SPARSH for an amount of Rs.86 lakh being **second installment central share**. The category wise split up of funds under various categories for the scheme along with the corresponding State

share is as follows:

2. The fund released is for implementation of the activities approved under AAP for the year 2025-26 through SNA SPARSH. Since the scheme is new and the budget heads are newly created, the Director of Agriculture as per letter read as 7th paper above has requested to release the funds through additional authorisation. As per Government order read as 8th paper above, an amount of **₹1,43,34,000/-** (Rupees One Crore Forty Three Lakh Thirty Four Thousand only) was additionally authorised to facilitate the release of the **second installment** of the Central and corresponding State shares for the General, SCP, and TSP components of the Scheme, National Mission for Natural Farming(NMNF) 2025-26.

3. Government have examined the matter in detail and are pleased to accord sanction to release a total amount of **₹1,43,34,000/-** (*Rupees One Crore Forty Three Lakh Thirty Four Thousand only*) as **second installment** of funds for implementation of the scheme, National Mission for Natural Farming(NMNF) 2025-26 through SPARSH as detailed in the table below :

5. The Director of Agriculture after completion of the financial year should prepare a reconciled Statement of Expenditure (SoE) and furnish the same to Accountant General (Audit) as stipulated in Government Order read as 1st to 3rd papers above.
