### ORDER

As per letter read as 1st paper above the Director of Agriculture Development and Farmers' Welfare Department has informed that as per the directions of Government of India, an Escrow Account has been opened for the purpose of depositing the advance premium subsidy w.e.f Kharif 2025. The NCIP Portal for enrollment of farmers for Rabi, 2025 will be opened only upon receipt of the advance share for the season. Hence he has requested to release advance state share premium of Rs. 13,92,13,046.88/- towards Rabi, 2025 to be deposited in Escrow Account.

2. As per Government order read as 2nd paper above, an amount of Rs.13,92,14,000/- (Rupees Thirteen Crore Ninety Two Lakh Fourteen

Thousand Only) has been authorised as additional expenditure under the Head of account 2401-00-109-65-02 (P) to facilitate the payment of advance state share premium subsidy of Rabi 2025 under RWBCIS scheme.

Government have examined the matter, and are pleased to release the amount to the tune of Rs.13,92,14,000/- (Rupees Thirteen Crore Ninety Two Lakh Fourteen Thousand Only) sanctioned as per GO read 2nd paper above to facilitate the payment of advance state share premium subsidy of Rabi 2025 under RWBCIS scheme

4. The Director of Agriculture is authorized to draw and disburse the amount to Agriculture Insurance Company of India Ltd (AICIL) during the current Financial Year.
