ORDER

- 1. The Principal Director, LSGD, vide letter read as 3rd paper above has furnished the proposal for granting Non Cadre placement under Career Advancement Scheme to 34 Assistant Engineers on completion of 8 years of continuous service.
- 2. The Principal Director has reported that no disciplinary action or Vigilance case is pending against these Assistant Engineers. All these incumbents have satisfactorily declared their probation and have completed 8 years of continuous service in Assistant Engineer Cadre and none of them granted TBHG promotion.
- 3. It was specifically mentioned in para(7) of the pay revision order issued vide G.O(P) No.27/2021/Fin dated 10.02.2021, that detailed orders on Career Advancement Scheme (CAS) would be issued separately. Subsequently, the Finance Department on 19.07.2022 directed the Principal Director to withhold proposals until a final clearance is made by Govt. in this regard. Now, vide letter read as 2nd paper above, the Finance Department has issued instructions to the the Principal Director to implement the CAS.

- 4. Government have examined the matter in detail and are pleased to grant Ist Non Cadre placement under Career Advancement Scheme to 34 Assistant Engineers as detailed in below to this GO, in the pay scale of Rs. 59300- 120900 with fixation under Rule 28A Part I KSR w.e.f dates noted against their name, as per provisions in GO read as 1st paper above.
- 5. The placement granted as per this order is subject to following conditions.
 - i)This order is subject to the verification of the Accountant General Kerala.
 - ii)If any amount drawn by the incumbent by this order is found to be in excess due to mistake or any other reason, noticed later, he/ she would be liable to refund the amount so received in lump unconditionally.
