## **ORDER**

Government have accorded administrative sanction for an amount of Rs.960 Lakh under the scheme of ASUMP 2025-26 for the component 'Mobility', for the procurement of 55 vehicles under various categories, for the LWE affected districts, as per Government order read as 1<sup>st</sup> paper above. Accordingly, bidding has been done by the Police Department to procure the vehicles and supply order for 55 vehicles has been placed.

2) The State Police Chief, as per letter read as 2 <sup>nd</sup> paper above, has reported that due to difference in GST, an amount of Rs.125.55480 Lakh left as savings and a Specification Committee was constituted for drafting specification of the suitable vehicles for Police Department which can be procured utilizing the savings. Accordingly, the Specification Committee drafted specifications for the procurement of 19 Light Motor Vehicles for intelligence collection in LWE affected areas. Therefore the State Police Chief has requested to accord revised administrative sanction for an amount of Rs.125.55480 Lakh for procuring 19 Light Motor Vehicles for intelligence

collection and surveillance operations in LWE affected districts of Kerala by utilizing the savings amount of ASUMP 2025-26 under the component 'Mobility'.

3) Government have examined the matter in detail and are pleased to accord administrative sanction for the procurement of 12 Light Motor Vehicles, each costing below Rs.10 Lakh, utilising the savings of Rs.1,25,00,000/- (One Crore Twenty Five Lakhs Only) left under the head of account "2055-115-99 Plan 01-Central Share" under the 'Mobility' component of the current year's ASUMP scheme, exclusively for allocation to Police stations and special units/battalions located in the formerly LWE affected districts.

4) The State Police Chief shall ensure that the purchases strictly comply with the ASUMP guidelines for LWE districts.
