**ORDER**

As per the Government Order read 1<sup>st</sup> paper above, Administrative Sanction for an amount of ₹1,18,93,000/- (Rupees One Crore Eighteen Lakh Ninety-three Thousand Only) under the Head of Account: 2235-02-103-80-35-P(V), has been accorded for the Administrative Expenses of the Gender Park, for the year 2025-2026. The budget provision for the year 2025-2026, under the above Head of Account is ₹900.00 Lakh. Accordingly, as per the Government Orders read as 2<sup>nd</sup> and 3<sup>rd</sup> papers above, an amount of ₹25,00,000/- (Rupees Twenty-five Lakh Only) and an amount of ₹30,00,000/- (Rupees Thirty Lakh Only) were released as the first and second installments respectively, to meet the administrative expenses of the Gender Park, for the current fiscal year.

2. Now Director of the Gender Park as per the letter read as 4<sup>th</sup> paper above, has submitted a proposal for the release of ₹15,00,000/- (Rupees

Fifteen Lakh Only) as the 3<sup>rd</sup> installment, to meet the administrative expenses remaining for the current fiscal year. As per the utilization certificate furnished by the Director, the balance amount outstanding with the PSTSB A/c of the Gender Park is ₹8,65,290/- (Rupees Eight Lakh Sixty-five Thousand Two Hundred and Ninety Only).

3. Having examined the matter in detail Government is pleased to accord the release of an amount of ₹15,00,000/- (Rupees Fifteen Lakh Only) from the Head of Account: 2235-02-103-80-35-P(V) and to credit the same to the PSTSB A/c No. 799012700001171 of the Gender Park in District Treasury, Kozhikode as the third installment for meeting the Administrative Expenses of The Gender Park, for the current fiscal year.
