ORDER

As per the G.O read as 1 st paper above Administrative sanction was accorded to plan schemes of Kerala State Pollution Control Board during current Financial Year 2022-23 for a total amount of Rs.500 Lakh. The Member Secretary Kerala State Pollution Control Board as per letter read as 2nd paper above has reported that an amount of Rs 80 Lakh was earmarked for strengthening of Board's Laboratories based on the estimate obtained during the Financial Year 2021-22. On receiving the actual bill, it is seen that an amount of Rs. 2,67,365/- is additionally incurred towards the purchase of equipment listed under the sub scheme Plan I(i) Strengthening of Board's Laboratories. An amount of Rs 60 Lakh was earmarked towards the purchase of Micro Balance under Plan III (i), but actual bill received for the equipment is Rs. 48,60,450/-. Hence an excess amount of Rs. 11,39,550/- is available under Plan III (i) - Ambient Air and Water Quality Monitoring Surveillance Programme. Hence the

Member Secretary, Kerala State Pollution Control Board has requested to accord sanction for utilizing the available excess amount under Plan III (i) Ambient Air and Water Quality Monitoring Surveillance Programme for meeting the additional expenditure incurred under Plan I(i) Strengthening of Board's Laboratories.

2. Government have examined the matter in detail and are pleased to accord sanction for utilizing an amount of Rs.2,67,365/- from sub component-III(i)-Ambient Air and Water Quality Monitoring Programme towards the additional expenses incurred under Plan I (i) Strengthening of Board's Laboratories.
