### **ORDER**

The Ministry of Home Affairs, as per letter read as 2<sup>nd</sup> paper above, has informed that an amount of Rs.5.14 Crore has been sanctioned to the State of Kerala under the Scheme “Assistance to States and UTs for Modernisation of Police” (ASUMP) 2024-2025. The State Police Chief, as per letter read as 3<sup>rd</sup> paper above, has requested to accord sanction for transferring the allotted amount along with corresponding state share to Single Nodal Account (SNA) as per the instructions in the Government order read as 1st paper above.

2) In the circumstance, Government are pleased to accord sanction for releasing an amount Rs.5,14,00,000/- (Rupees Five Crore Fourteen Lakh Only) under the head of account 2055-00-115-99-01-PV towards Central share and Rs.3,42,66,000/- (Rupees Three Crore Forty Two Lakh and Sixty Six Thousand Only) under the head of account 2055-00-115-99-02 PV as corresponding State share and for transferring a

total amount of Rs.8,56,66,000/- (Rupees Eight Crore Fifty Six Lakh and Sixty Six Thousand Only) to the SNA Account maintained by the Additional Assistant Inspector General of Police, under the scheme “Assistance to States and UTs for Modernisation of Police”.

3) An amount of Rs.3,42,66,000/- (Rupees Three Crore Forty Two Lakh and Sixty Six Thousand Only) is additionally authorized under the head of account 2055-00-115-99-02 PV, as per the Government order read as 4<sup>th</sup> paper above, for the purpose.

4) The SNA Officer shall adhere to the guidelines and instructions issued by the Central Ministry and the State Government from time to time.
