### ORDER

As per the letter read above, the Director of Fisheries furnished the proposal for the project 'Group Personal Accident Insurance Scheme for Fishermen' at an estimated cost of Rs.14,86,58,454/- and has requested to issue administrative sanction for the same.

2) The objectives of the scheme are as follows :-

- To provide social security to active fishermen and the dependents.
- To cover the risk due to accident while fishing leading to death, permanent disability, partial disability etc.

3) All fishermen registered with Kerala Fishermen Welfare Fund Board between the age of 18 to 70 will be the beneficiaries of the scheme. The implementation agency of the project is Kerala Fishermen Welfare Fund Board.
