### ORDER

As per the Government Order read as 1st paper above, administrative sanction was issued for an amount of ₹250.00 Lakh under the Head of Account '4215-01-800-81 Plan-V for the implementation of the scheme Project Management and Monitoring under State Plan Scheme 2025-26.

2. As per the letter read as 2nd paper above, the Executive Director, Jalanidhi has informed that the amount earmarked under the scheme 'Project Management and Monitoring' is to meet project management expenses including salary and wages for 5 months and infrastructure development for smooth and efficient functioning of various programmes and has requested to release the amount of Rs.2,50,00,000/- for meeting the immediate expenses to KRWSA from the budget provision under the Head of Account '4215-01-800-81 Plan-V

3. Government have examined the matter in detail and are pleased

to release an amount of Rs.1,00,00,000/-(Rupees One Crore only) under H/A 4215-01-800-81-00- 00-00-P-V, subject to the following terms and conditions of fund release:

- i. The amount released shall be transfer credited to PSTSB account in compliance of GO(P)62/2018/Fin dated 16/4/2018.
- ii. The instructions in Circular No.84/2008/fin dated 09/12/08, Circular No.8/2018/fin dated 30/01/2018 & G.O(Ms) No.93/2020/Fin dated 11.09.2020 shall be scrupulously followed.
- iii. The Executive Director, Jananidhi shall furnish duly authenticated detailed component wise statement of expenditure and Utilization Certificate as per instructions in GO.(Ms)No.4/2020/Fin dated 09/01/2020.
- iv. If there is un-utilized amount at the end of this financial year that should be refunded to the government during the financial year itself."
