As per the Government Order read above Government made relaxation in the norms being followed by State Government, for the adoption of World Bank procurement regulations for the execution of works under Kerala Solid Waste Management Project by Urban Local Bodies. In the Government Order it was ordered, among other things, that concurrence of Government is needed for the approval of single bids at first instance of tendering.

The Project Director, KSWMP, as per the letter above, has informed that many Urban Local Bodies have been compelled to cancel & retender such bids considering the time lag involved in getting Government approval for small value works in cases where there is single bids at first instance of tendering, in the light of the stipulation in the Government Order. In the circumstance, Project Director, KSWMP has requested to reconsider the current provision related to Government concurrence regarding acceptance of single bids, in line with World Bank regulations & provisions outlined in DEA's Manual for Procurement of Works.

Government examined the matter in detail and are pleased to order that single tender beyond the limits of acceptance as per the Government Orders in force shall be submitted for concurrence of Government.
