In exercise of the powers conferred by 2nd proviso to subsection 7 of section 19 of the Right to Fair Compensation and Transparency in Land Acquisition, Rehabilitation and Resettlement Act, 2013 (Central Act 30 of 2013), the Government of Kerala hereby extend the time limit in publishing the declaration as per sub-section 1 of section 19 to the Notification issued under sub-section (1) of section 11 as per G.O(P) No. 79/2023/RD dated 12th March 2023 and published in the Extra Ordinary Gazette No. 902 dated 13th March 2023, namely:-



### Extension

Notification No. G.O(P) No. 79/2023/RD dated 12th March 2023 and published in the Extra Ordinary Gazette No. 902 dated 13th March 2023 has been issued in accordance with the provisions of sub-section (1) of section 11 of the Right to Fair Compensation and Transparency in Land Acquisition, Rehabilitation and Resettlement Act, 2013 with regard to the acquisition of 6.6290 Hectares of land in Neyyatinkara, Kollayil, Parasuvaikkal & Parasala villages for the doubling of railway line from Neyyatinkara to Parasala & 0.3592 Hectares of land for the construction of ROB's in the Neyyatinkara to Parasala stretch (3rd stretch).

AND WHEREAS, the District Collector, Thiruvananthapuram has reported that as per Section 19(7) of LARR Act, 2013 mentions that the 19(1) Declaration has to be published within 12 months from the date of issuance of 11(1) Notification (preliminary notification) and that the 11(1) Notification issued as per G.O(P) No. 79/2023/RD dated 12th March 2023 and published in the Extra Ordinary Gazette No. 902 dated 13th March 2023, will expire on 12.03.2024 and therefore requested to extend the time limit for publishing the 19(1) Declaration.

NOW THEREFORE, sanction is accorded to extend the time limit in publishing the Declaration for a further period of six months from the date of expiry of the 11(1) notification ie. 12.03.2024 by invoking the provisions contained in 2nd proviso to Section 19(7) of the LARR Act, 2013 with regard to the acquisition of 6.6290 Hectares of land in Neyyatinkara, Kollayil, Parasuvaikkal & Parasala villages for the doubling of railway line from Neyyatinkara to Parasala & 0.3592 Hectares of land for the construction of ROB's in the Neyyatinkara to Parasala stretch (3rd stretch) subject to the condition that no more extension will be allowed under any circumstances.
