Explanatory Note

(This does not form part of the notification, but is intended to indicate its general purport.)

The Government of Kerala have reconstituted the Juvenile Justice Boards for fourteen Districts in the State of Kerala as per notification issued under G.O.(P) No.9/2022/WCDD dated 16th June, 2022 and published as S.R.O. No.614/2022 in the Kerala Gazette Extraordinary No.2040 dated 21st June, 2022. In the said notification serial No.IX, Juvenile Justice Board for Palakkad District, Adv. Aparna Narayanan R., Janani, Thekethara, Akathethara, Palakkad-678008 was nominated to the said Board as a member representing as social worker. Now she has resigned from the said Board and the vacancy arose.
