## **Explanatory Note**

(This does not form part of the notification, but is intended to indicate its general purport.)

The term of office of the committee appointed as per notification issued under G.O. (P) No.35/2023/LBR. dated 27<sup>th</sup> March, 2023 and published as S.R.O. No. 426/2023 in the Kerala Gazette Extraordinary No.1157 dated 28<sup>th</sup> March, 2023, to hold enquiries and to advise the Government in the matter of revision of minimum rates of wages payable to the employees in the Cashew Industry in the State of Kerala expired on 27<sup>th</sup> September, 2023. Now, the Government have decided to extend the term of office of the said committee for a further period upto 31<sup>st</sup> March, 2024 with effect from 28<sup>th</sup> September, 2023 to enable the said committee to complete its work.

The notification is intended to achieve the above object.
