In exercise of the powers conferred by 2nd proviso to subsection 7 of section 19 of the Right to Fair Compensation and Transparency in Land Acquisition, Rehabilitation and Resettlement Act, 2013 (Central Act 30 of 2013), the Government of Kerala hereby extend the time limit in publishing the declaration as per sub-section 1 of section 19 to the Notification issued under sub-section (1) of section 11 as per Proceedings No. C-368/19 dated 20th September, 2022 and published in the Extra Ordinary Gazette No. 3274 dated 24th September, 2022 namely :-



Proceedings No. C-368/19 dated 20th September, 2022 and published in the Extra Ordinary Gazette No. 3274 dated 24th September, 2022 has been issued in accordance with the provisions of sub-section (1) of section 11 of the Right to Fair Compensation and Transparency in Land Acquisition, Rehabilitation and Resettlement Act, 2013 with regard to the acquisition of 1.85 Ares of land in Nilamboor Village of Malappuram district for the construction of Railway Over Bridge in lieu of Railway LC No. 12 at Nilambur yard.

AND WHEREAS, the District Collector, Malappuram has reported that as per Section 19 (7) of LARR Act, 2013, the 19 (1) Declaration has to be published within 12 months from the date of issuance of 11(1) Notification (preliminary notification) and that the 11(1) Notification issued as per Proceedings No. C-368/19 dated 20th September, 2022 and published in the Extra Ordinary Gazette No. 3274 dated 24th September, 2022 and extended as per G.O.(P)No.254/2023/RD dated 29/09/2023 and published in the Extra Ordinary Gazette No.3192 dated 30/09/2023 will expire on 22/03/2024 and therefore requested to extend the time limit for publishing the 19(1) Declaration.

NOW THEREFORE, sanction subject tois accorded to extend the time limit in publishing the Declaration for a further period of 6 months from the date of expiry of the 11(1) notification ie. 22/03/2024 by invoking the provisions contained in 2nd proviso to Section 19(7) of the LARR Act, 2013 with regard to the acquisition of 1.85 Ares of land in Nilamboor Village of Malappuram district for the construction of Railway Over Bridge in lieu of Railway LC No. 12 at Nilambur yard, as the last chance on the condition that no more extension be granted under any circumstances.
