In exercise of the powers conferred by 1st proviso to Section 25 of the Right to Fair Compensation and Transparency in Land Acquisition, Rehabilitation and Resettlement Act, 2013 (Central Act 30 of 2013), the Government of Kerala hereby extend the time limit in publishing the Award as per Section 25 to the Declaration issued under subsection (1) of Section 19 as per Proceedings No. K3-3156/18 dated 03rd December 2022 and published in the Extra Ordinary Gazette No. 4145 dated 06th December 2022 namely:-



## Extension

As per Proceedings No. K3-3156/18 dated 03 rd December 2022 and published in the Extra Ordinary Gazette No. 4145 dated 06th December 2022, the Declaration in accordance with the provisions of subsection (1) of Section 19 of the Right to Fair Compensation and Transparency in Land Acquisition, Rehabilitation and Resettlement Act, 2013 with regard to the acquisition of land in Sharkara Village of Thiruvananthapuram district for the construction of bridge across TS Canal near Thekke - Arayathuruthu has been issued.

AND WHEREAS, the District Collector, Thiruvananthapuram has reported that as per Section 25 of LARR Act, 2013 mentions that the Collector shall make an Award within a period of 12 months from the date of issuance of 19(1) Declaration ie, the 19(1) Declaration issued as per Proceedings No.K3-3156/18 dated 03rd December 2022 and published in the Extra Ordinary Gazette No. 4145 dated 06th December 2022 and extended as per G.O.(P)No.303/2023/RD dated 01/12/2023 and published in the Extra Ordinary Gazette No. 3912 dated 01/12/2023 will expire on05/06/2024, and therefore requested to extend the time limit in publishing the Award.

NOW THEREFORE, sanction is accorded to extend the time limit in publishing the Award for a further period of 6 months from the date of expiry of the 19(1) Declaration ie, 05/06/2024 by invoking the provisions contained in 1st proviso to Section 25 of the LARR Act, 2013 with regard to the acquisition of land in Sharkara Village of Thiruvananthapuram district for the construction of bridge across TS Canal near Thekke - Arayathuruthu subject to the condition that no more extension be allowed under any circumstances.
