In exercise of the powers conferred by 1st proviso to Section 25 of the Right to Fair Compensation and Transparency in Land Acquisition, Rehabilitation and Resettlement Act, 2013 (Central Act 30 of 2013), the Government of Kerala hereby extend the time limit in publishing the Award as per Section 25 to the Notification issued as per subsection (1) of section 19 issued as per G.O.(P) No. 199/2022/RD dated 11th July, 2022 and published in the Extra Ordinary Gazette No. 2298 dated 11th July, 2022 namely :-

G.O.(P) No. 199/2022/RD dated 11th July, 2022 and published in the Extra Ordinary Gazette No. 2298 dated 11th July, 2022, has been issued in accordance with the provisions of sub-section (1) of section 19 of the Right to Fair Compensation and Transparency in Land Acquisition, Rehabilitation and Resettlement Act, 2013 with regard to the acquisition of 2.3104 Hectares of land in Kasaba, Katcheri, Vengeri and Chevayur Villages of Kozhikkode district for the widening of Mananchira - Vellimadukunnu road.

AND WHEREAS, the District Collector, Kozhikkode has reported that as per Section 25 of LARR Act, 2013 mentions that the Collector shall make an Award within a period of 12 months from the date of issuance of 19(1) Declaration ie. the 19(1) Declaration issued as per G.O.(P) No. 199/2022/RD dated 11th July, 2022 and published in the Extra Ordinary Gazette No. 2298 dated 11th July, 2022 and extended as per G.O.(P)No. 265/2023/RD dated 17th October, 2023 and published in the Extra Ordinary Gazette No. 3389 dated 18th October, 2023 expired on 10.01.2024, and therefore requested to extend the time limit in publishing the Award.

NOW THEREFORE, sanction is accorded to extend the time limit in publishing the Award for a period of 6 months from the date of expiry of the 19(1) Declaration ie. 10.01.2024 by invoking the provisions contained in 1st proviso to Section 25 of the LARR Act, 2013 with regard to the acquisition of 2.3104 Hectares of land in Kasaba, Katcheri, Vengeri and Chevayur Villages of Kozhikkode district for the widening of Mananchira – Vellimadukunnu road, as the last chance on the condition that no more extension be allowed under any circumstances.
