In exercise of the powers conferred by 2nd proviso to subsection 7 of section 19 of the Right to Fair Compensation and Transparency in Land Acquisition, Rehabilitation and Resettlement Act, 2013 (Central Act 30 of 2013), the Government of Kerala hereby extend the time limit in publishing the declaration as per sub-section 1 of section 19 to the Notification issued under subsection (1) of section 11 as per G.O.(P)No. 74/2022/RD dated 23rd February 2022 and published in the Extra Ordinary Gazette No. 633 dated 25th February 2022, namely:-



## Extension

As per G.O.(P)No.74/2022/RD dated 23rd February 2022 and published in the Extra Ordinary Gazette No.633 dated 25th February 2022, notification in accordance with the provisions of subsection (1) of section 11 of the Right to Fair Compensation and Transparency in Land Acquisition, Rehabilitation and Resettlement Act, 2013 with regard to the acquisition of 30.1268 Hectares of land in Choornikkara, Keezhmadu, Aluva West and Thrikkakara North Villages of Ernakulam District for the construction of Seaport - Airport road Phase II, Section A Package 2&3 - NAD Junction to Assissi Junction, Assissi Junction to Mahilayalam Junction has been issued.

AND WHEREAS, the District Collector, Ernakulam has reported that as per Section 19(7) of LARR Act, 2013 mentions that the 19(1) Declaration has to be published within 12 months from the date of issuance of 11(1) Notification (preliminary notification) and that the 11(1) Notification issued as per G.O.(P)No.74/2022/RD dated 23rd February 2022 and published in the Extra Ordinary Gazette No.633 dated 25th February 2022 and extended as per G.O.(P) No. 31/2023/RD dated 03rd February 2023 and published in the Extra Ordinary Gazette No. 416 dated 03rd February 2023 & G.O. (P)No.187/2023/RD dated 07th August 2023 and published in the Extra Ordinary Gazette No.2614 dated 07th August 2023, will expire on 23/02/2024 and therefore requested to extend the time limit for publishing the 19(1) Declaration.

NOW THEREFORE, sanction is accorded to extend the time limit in publishing the Declaration for a further period of 6 months from the date of expiry of the 11(1) notification ie. 23/02/2024 by invoking the provisions contained in 2nd proviso to Section 19(7) of the LARR Act, 2013 with regard to the acquisition of 30.1268 Hectares of land in Choornikkara, Keezhmadu, Aluva West and Thrikkakara North Villages of Ernakulam District for the construction of Seaport - Airport road Phase II, Section A Package 2&3 - NAD Junction to Assissi Junction, Assissi Junction to Mahilayalam Junction, on the condition that if the 19(1) declaration is not issued within the extended period, then fresh acquisition proceedings needs to be initiated.
