Now, THEREFORE, in exercise of the powers conferred by sub-sections (1) and (2) of section 110 of the Kerala Police Act, 2011 (8 of 2011), the Government of Kerala hereby appoint Justice Sri. V. K. (Rt.) No. 475/2012/Home dated 17<sup>th</sup> February, 2012 and published as S. R. O. No. 108/2012 in the Kerala Gazette Extraordinary No. 331 dated 18<sup>th</sup> February, 2012.

As per notification issued under G. O. (Ms.) No. 112/2020/Home dated 22<sup>nd</sup> May, 2020 and published as S. R. O. No. 340/2020 in the Kerala Gazette Extraordinary No. 1248 dated 22<sup>nd</sup> May, 2020, Sri.V. K. Mohanan, Retired High Court Judge was appointed as the Chairperson of the State Police Complaints Authority. Since his term of office expires on 30<sup>th</sup> May, 2023, the Government have decided to appoint Justice Sri. V. K. Mohanan, (Retired High Court Judge) as Chairperson of the State Police Complaints Authority w.e.f. 31<sup>st</sup> May, 2023.

The notification is intended to achieve the above object.
