In exercise of the powers conferred by 1st proviso to Section 25 of the Right to Fair Compensation and Transparency in Land Acquisition, Rehabilitation and Resettlement Act, 2013 (Central Act 30 of 2013), the Government of Kerala hereby extend the time limit in publishing the Award as per Section 25 to the Declaration issued under subsection (1) of Section 19 as per G.O(P) No. 217/2022/RD dated 12th August 2022 and published in the Extra Ordinary Gazette No. 2687 dated 12th August 2022 namely:-



Extension

As per G.O(P) No. 217/2022/RD dated 12th August 2022 and published in the Extra Ordinary Gazette No. 2687 dated 12th August 2022, the Declaration in accordance with the provisions of subsection (1) of Section 19 of the Right to Fair Compensation and Transparency in Land Acquisition, Rehabilitation and Resettlement Act, 2013 with regard to the acquisition of 3.9908 hectares of land in Vizhinjam & Kottukal Villages of Thiruvananthapuram district for the construction of Vizhinjam International Seaport Ltd has been issued.

AND WHEREAS, the District Collector, Thiruvananthapuram has reported that as per Section 25 of LARR Act, 2013 mentions that the Collector shall make an Award within a period of 12 months from the date of issuance of 19(1) Declaration i.e, the 19(1) Declaration issued as per G.O(P) No.217/2022/RD dated 12th August 2022 and published in the Extra Ordinary Gazette No. 2687 dated 12th August 2022 and extended as per G.O(P) No. 196/2023/RD dated 17th August 2023 and published in the Extra Ordinary Gazette No. 2716 dated 17th August 2023, expired on 12.02.2024, and therefore requested to extend the time limit in publishing the Award.

NOW THEREFORE, sanction is accorded to extend the time limit in publishing the Award for a further period of 6 months from the date of expiry of the 19(1) Declaration i.e 12.02.2024 by invoking the provisions contained in 1st proviso to Section 25 of the LARR Act, 2013 with regard to the acquisition of 3.9908 hectares of land in Vizhinjam & Kottukal Villages of Thiruvananthapuram district for the construction of Vizhinjam International Seaport Ltd subject to the condition that no more extension be granted under any circumstances.
