In exercise of the powers conferred by 2nd proviso to subsection 7 of section 19 of the Right to Fair Compensation and Transparency in Land Acquisition, Rehabilitation and Resettlement Act, 2013 (Central Act 30 of 2013), the Government of Kerala hereby extend the time limit in publishing the declaration as per sub-section 1 of section 19 to the Notification issued under sub-section (1) of section 11 as per Proceedings No. DCKKD/1577/2020-B1 dated 04th August, 2021 and published in the Extra Ordinary Gazette No. 2326 dated 06th August, 2021, namely:-

Proceedings No. DCKKD/1577/2020-B1 dated 04th August, 2021 and published in the Extra Ordinary Gazette No. 2326 dated 06th August, 2021 has been issued in accordance with the provisions of sub-section (1) of section 11 of the Right to Fair Compensation and Transparency in Land Acquisition, Rehabilitation and Resettlement Act, 2013 with regard to the acquisition of 0.8946 Hectares of land in Karuvanthuruthy and Beypore Villages of Kozhikode district for the construction of Beypore bridge across Chaliyar river for coastal highway.

AND WHEREAS, the District Collector, Kozhikode has reported that as per Section 19(7) of LARR Act, 2013 mentions that the 19(1) Declaration has to be published within 12 months from the date of issuance of 11(1) Notification (preliminary notification) and that the 11(1) Notification issued as per Proceedings No. DCKKD/1577/2020-B1 dated 04th August, 2021 and published in the Extra Ordinary Gazette No. 2326 dated 06th August, 2021 and extended as per G.O(P) No. 219/2022/RD dated 16th August, 2022 and published in the Extra Ordinary Gazette No. 2712 dated 17th August 2022, G.O.(P)No. 40/2023/RD dated 08th February 2023 and published in the Extra Ordinary Gazette No. 473 dated 09th February 2023 and G.O(P) No. 236/2023/RD dated 23rd September 2023 and published in the Extra Ordinary Gazette No. 3133 dated 25th September 2023 expired on 04.02.2024 and therefore requested to extend the time limit for publishing the 19(1) Declaration.

NOW THEREFORE, sanction is accorded to extend the time limit in publishing the Declaration for a further period of 6 months from the date of expiry of the 11(1) notification ie. 04.02.2024 by invoking the provisions contained in 2nd proviso to Section 19(7) of the LARR Act, 2013 with regard to the acquisition of 0.8946 Hectares of land in Karuvanthuruthy and Beypore Villages of Kozhikode district for the construction of Beypore bridge across Chaliyar river for coastal highway subject to the condition that if the 19(1) declaration is not published within the extended time limit then fresh acquisition.
