In exercise of the powers conferred by 2nd proviso to subsection 7 of section 19 of the Right to Fair Compensation and Transparency in Land Acquisition, Rehabilitation and Resettlement Act, 2013 (Central Act 30 of 2013), the Government of Kerala hereby extend the time limit in publishing the declaration as per sub-section 1 of section 19 to the Notification issued under sub-section (1) of section 11 as per Proceedings No A-99/2020 dated 12th April 2023 and published in the Extra Ordinary Gazette No 1374 dated, 18th April 2023, namely:-

Proceedings No A-99/2020 dated 12th April 2023 and published in the Extra Ordinary Gazette No 1374 dated 18th April 2023 has been issued in accordance with the provisions of sub-section (1) of section 11 of the Right to Fair Compensation and Transparency in Land Acquisition, Rehabilitation and Resettlement Act, 2013 with regard to the acquisition of land for the construction of ROB in lieu of Railway LC No 06 between Cherukara & Angadipuram stations.

AND WHEREAS, the District Collector, Malappuram has reported that as per Section 19(7) of LARR Act, 2013, the 19(1) Declaration has to be published within 12 months from the date of issuance of 11(1) Notification (preliminary notification) and the 11(1) Notification issued as per Proceedings No A-99/2020 dated 12th April 2023 and published in the Extra Ordinary Gazette No 1374 dated 18th April 2023, will expire on 17/04/2024 and therefore requested to extend the time limit in publishing the declaration.

NOW THEREFORE, sanction is accorded to extend the time limit in publishing the 19(1) declaration for a further period of 6 months from the date of expiry of the 11(1) Notification ie. 17/04/2024 by invoking the provisions contained in 2nd proviso to Section 19(7) of the LARR Act, 2013 with regard to the acquisition of land for the construction of ROB in lieu of Railway LC No 06 between Cherukara & Angadipuram stations subject to the condition that no more extension be granted under any circumstances.
