The following draft rules to amend the Kerala Food Security Rules, 2018 which the Government of Kerala propose to make in exercise of the powers conferred by section 40 of the National Food Security Act, 2013 (Central Act 20 of 2013) is hereby published for general information, as required by sub-section (1) of the said section.



Notice is hereby given that the said draft rules will be taken up for consideration on or after thirty days from the date of publication of this notification in the Official Gazette and that any objections or Suggestions which may be received from any person on or before the time limit specified above in respect of the said draft rules will be considered by the Government. ## DRAFT RULES

- 1. Short title and commencement.—(1) These rules may be called the Kerala Food Security (Amendment) Rules, 2023.
  - (2) They shall come into force at once.
  - 2. Amendment of the Rules.—In the Kerala Food Security rules, 2018, in rule 47,—
- (1) in sub-rule (1), in item (iv), for the words "and in the Legislative Assembly" the words "or in the Legislative Assembly" shall be substituted;
  - (2) for sub-rule (6) the following sub-rule shall be substituted, namely:—
- "(6) The Chairman of the Fair Price Shop Level Vigilance Committee shall preside over the meetings and in his absence, the Ward Member or any Standing Committee Member of the concerned local body authorized by the Chairman shall preside over the meetings and in his absence, a member chosen by the members from among the members present shall preside over the meetings."
