In exercise of the powers conferred by 2nd proviso to subsection 7 of section 19 of the Right to Fair Compensation and Transparency in Land Acquisition, Rehabilitation and Resettlement Act, 2013 (Central Act 30 of 2013), the Government of Kerala hereby extend the time limit in publishing the declaration as per sub-section 1 of section 19 to the Notification issued under sub-section (1) of section 11 as per Proceedings No. DCKNR/3509/2020-C3 dated 23rd August 2022 and published in the Extra Ordinary Gazette No. 2922 dated 29th August 2022, namely:-

Proceedings No. DCKNR/3509/2020-C3 dated 23rd August 2022 and published in the Extra Ordinary Gazette No. 2922 dated 29th August 2022 has been issued in accordance with the provisions of sub-section (1) of section 11 of the Right to Fair Compensation and Transparency in Land Acquisition, Rehabilitation and Resettlement Act, 2013 with regard to the acquisition of 36.34 Hectares of land in Thiruvangadu & Kodiyeri Villages of Kannur district for the construction of ROB at LC No. 225 between Thalassery & Mahe Stations.

AND WHEREAS, the District Collector, Kannur has reported that as per Section 19(7) of LARR Act, 2013 mentions that the 19(1) Declaration has to be published within 12 months from the date of issuance of 11(1) Notification (preliminary notification) and that the 11(1) Notification issued as per Proceedings No. DCKNR/3509/2020-C3 dated 23rd August 2022 and published in the Extra Ordinary Gazette No. 2922 dated 29th August 2022 and extended as per G.O(P) No. 184/2023/RD dated 02nd August 2023 and published in the Extra Ordinary Gazette No. 2568 dated 03rd August 2023, will expire by 28.02.2024 and therefore requested to extend the time limit for publishing the 19(1) Declaration.

NOW THEREFORE, sanction is accorded to extend the time limit in publishing the Declaration for a further period of six months from the date of expiry of the 11(1) notification ie. 28.02.2024 by invoking the provisions contained in 2nd proviso to Section 19(7) of the LARR Act, 2013 with regard to the acquisition of 36.34 Hectares of land in Thiruvangadu & Kodiyeri Villages of Kannur district for the construction of ROB at LC No. 225 between Thalassery & Mahe Stations as the last chance on the condition that no more extension be allowed under any circumstances.
