In exercise of the powers conferred by clause (a) of sub-section (1) of section 5 read with section 9 of the Minimum Wages Act, 1948 (Central Act 11 of 1948), the Government of Kerala hereby make the following amendment to the notification issued under G.O.(P) No.40/2023/LBR. dated 12<sup>th</sup> April, 2023 and published as S.R.O. No. 489/2023 in the Kerala Gazette Extraordinary No.1352 dated 17<sup>th</sup> April, 2023, namely:-



## AMENDMENT

In the said notification,-

(i) in the operating part, for the words "and Khadi Industry", the symbol and words ", Khadi Industry, Furniture Industry and Block Rubber Factories Industry" shall be substituted;

(ii) in Para I, at the end, for the words, "and the Photography and Videography", the symbol and words ", Photography and Videography and the Furniture Industry" shall be substituted;

(iii) in Para I, under the heading "1. Employees Representatives" for the entry against serial number 1, the following entry shall be substituted, namely:-

"Shri. T.P. Ramakrishnan M.L.A.,  
President, C.I.T.U, Kottarakkal Veedu, Velliyoor,  
Nochad P.O., Naduvannur, Kozhikode."

(iv) in Para III, at the end, for the words "and Khadi Industry", the symbol and words ", Khadi Industry and the Block Rubber Factories Industry" shall be substituted;

(v) in the explanatory note, at the end, for the words "and Khadi Industry", the symbols and words ", Khadi Industry, Furniture Industry and Block Rubber Factories Industry" shall be substituted.

### Explanatory Note

(This does not form part of the notification, but is intended to indicate its general purport.)

As per notification issued under G.O. (P) No. 40/2023/LBR. dated 12<sup>th</sup> April, 2023 and published as S.R.O. No. 489/2023 in the Kerala Gazette Extraordinary No.1352 dated 17<sup>th</sup> April, 2023, the Government appointed three sub-committees to hold enquiries and to advise the Government in the matter of revision of minimum rates of wages payable to the employees. In exercise of the powers conferred by clause (a) of sub-section (1) of section 5 read with section 9 of the Minimum Wages Act, 1948 (Central Act 11 of 1948), the Government have decided to include the Furniture Industry sector in Sub-committee I and Block Rubber Factories Industry sector in Sub-committee III constituted as per the above said notification, so as to hold enquiries and to advise the



Government in the matter of revision of minimum rate of wages payable to the employees employed in the said sectors and also decided to appoint Shri. T.P. Ramakrishnan M.L.A., President, C.I.T.U, Kottarakkal Veedu, Velliyoor, Nochad P.O., Naduvannur, Kozhikode as an Employee Representative under Sub-committee I, in the place of Shri. Anathalavattam Anandan, Ananda Bhavan, Chirayinkeezhu, Thiruvananthapuram-695 304, and to make consequential amendments in the said notification.

The notification is intended to achieve the above object.
