WHEREAS, it appears to the Government of Kerala that the land specified in the Schedule below is needed or likely to be needed for a public purpose, to wit for the land acquisition of 12.7834 Hectares of land in Edakad, Kannur I, Kannur II & Pallikunnu Villages of Kannur district for the construction of Coastal Highway from Edakkad to Payyambalam beach (Reach III).

AND WHEREAS, in exercise of the powers conferred in sub-section (1) of section 4 of the Right to Fair Compensation and Transparency in land Acquisition, Rehabilitation and Resettlement Act, 2013 (Central Act 30 of 2013), Government of Kerala have decided to conduct a Social Impact Assessment in the area specified in the schedule below.



NOW THEREFORE, sanction is hereby accorded to Rajagiri College of Social Sciences (Autonomus), Kochi to conduct a Social Impact assessment Study and to prepare a Social Impact Assessment Plan as provided in the Act. The process shall be completed within a period of Three months in any case.
