In exercise of the powers conferred by section 4 of the Kerala Public Service Commission (Additional Functions as respects certain Corporations and Companies) Act, 1970 (19 of 1970), the Government of Kerala, hereby make the following rules further to amend the Kerala Public Service Commission (Consultation by Corporations and Companies) Rules, 1971, issued under G. O. (Ms.) No. 129/71/PD. dated 11th May, 1971 and published as S. R. O. No. 145/71 in the Kerala Gazette Extraordinary No. 245 dated 11th May, 1971, namely:—



RULES

1. *Short title and commencement.*—(1) These rules may be called the Kerala Public Service Commission (Consultation by Corporations and Companies) Amendment Rules, 2025.

(2) They shall come into force at once.

2. *Amendment of the rules.*—In the Kerala Public Service Commission (Consultation by Corporations and Companies) Rules, 1971, in clause (c) of rule 2, after item (xiii), the following item shall be added, namely:—

“(xiv) The Kerala Tailoring Workers’ Welfare Fund Board.”

Explanatory Note

(This does not form part of the notification, but is intended to indicate its general purport.)

As per the Kerala Public Service Commission (Additional Functions as respects certain Corporations and Companies) Amendment Act, 2024 (Act 29 of 2024) the Kerala Tailoring Workers’ Welfare Fund Board is included in clause (a) of section 2 of the Kerala Public Service Commission (Additional Functions as respects certain Corporations and Companies) Act, 1970 (19 of 1970). It is necessary to include the said Board in the Kerala Public Service Commission (Consultation by Corporations and Companies) Rules, 1971 so that the Board may seek the advice of the Kerala Public Service Commission on matters relating to methods of recruitment of its employees. Hence, the Government have decided to amend the said Rules suitably.

The notification is intended to achieve the above object.
