In exercise of the powers conferred by 2nd proviso to subsection 7 of section 19 of the Right to Fair Compensation and Transparency in Land Acquisition, Rehabilitation and Resettlement Act, 2013 (Central Act 30 of 2013), the Government of Kerala hereby extend the time limit in publishing the declaration as per sub-section 1 of section 19 to the Notification issued under sub-section (1) of section 11 as per G.O(P) No. 35/2021/RD dated 26th February 2021 and published in the Extra Ordinary Gazette No. 1006 dated 26th February 2021, namely:-

G.O(P) No. 35/2021/RD dated 26th February 2021 and published in the Extra Ordinary Gazette No. 1006 dated 26th February 2021 has been issued in accordance with the provisions of sub-section (1) of section 11 of the Right to Fair Compensation and Transparency in Land Acquisition, Rehabilitation and Resettlement Act, 2013 with regard to the acquisition of 4.4988 Hectares of land in Puthur and Kainoor Villages of Thrissur district for the construction of Puthur Zoological Park.

AND WHEREAS, the District Collector, Thrissur has reported that as per Section 19 (7) of LARR Act, 2013, the 19 (1) Declaration has to be published within 12 months from the date of issuance of 11(1) Notification (preliminary notification) and that the 11(1) Notification issued as per G.O(P) No. 35/2021/RD dated 26th February 2021 and published in the Extra Ordinary Gazette No. 1006 dated 26th February 2021 and extended as per G.O(P) No 16/2022/RD dated 06th January 2022 and published in the Extra Ordinary Gazette No.87 dated 06th January 2022, G.O(P) No.243/2022/RD dated 28th September 2022 and published in the Extra Ordinary Gazette No. 3324 dated 28th September 2022, G.O(P) No. 59/2023/RD dated 23rd February 2023 and published in the Extra Ordinary Gazette No. 667 dated 23rd February 2023, G.O(P) No. 191/23/RD dated 10th August 2023 and published in the Extra Ordinary Gazette No. 2674 dated 11th August 2023 & G.O. (P)No.31/2024/RD dated 25th January 2024 and published in the Extra Ordinary Gazette No.324 dated 27th January 2024 expired on 25.08.2024 and therefore requested to extend the time limit for publishing the 19(1) Declaration.

NOW THEREFORE, sanction is accorded to extend the time limit in publishing the Declaration for a further period of 6 months from the date of expiry of the 11(1) notification ie, 25.08.2024 by invoking the provisions contained in 2nd proviso to Section 19(7) of the LARR Act, 2013 with regard to the acquisition of 4.4988 Hectares of land in Puthur and Kainoor Villages of Thrissur district for the construction of Puthur Zoological Park.
